She has been a speaker for the National Child Protection Training Center, Minnesota CLE, National Center for Prosecution of Child Abuse, the Ontario Office of the Children’s Lawyer, and numerous statewide training conferences across the country. Ms. Mitnick served on the Minnesota Supreme Court Task Force on Parental Cooperation and the American Bar Association working group to update guidelines for child witnesses in criminal cases. She served on the AFCC Task Force on Court-Involved Therapy and is a board member of both AFCC and the Minnesota Chapter of AFCC.
